1. 5:00pm: Call to Order, determination of quorum

The meeting came to order at 5:05pm, all members were present.

2. 5:05pm: Review and approval of October meeting minutes

The October minutes were approved unanimously.

3. 5:10pm: Open Forum

There was one public speaker under open forum.

4. 5:15pm: Discuss and take possible action on Oakland Police Department Immigration Policy No. 415

The Committee reviewed the current OPD Immigration Policy 415 and had a lengthy discussion about the level of support OPD can provide when ICE conducts any operations in the City of Oakland. Of specific concern was the ICE operation that occurred on August in West Oakland in which OPD officers were dispatched to conduct traffic control at the perimeter of the operation.

Chairperson Hofer submitted a packet of material including press releases, media coverage, and information from ICE and the courts received through public records requests. He raised the concern that

although ICE claimed the operation was to stop a human trafficking ring, only one person was arrested on the day of the operation and they were taken into custody for only immigration violations. He also expressed concern that the Chief of Police had continued to misrepresent the operation after it was learned that the operation did not involve trafficking.

Lt. Hookfin, who was assigned to the operation, answered questions about establishing a perimeter and preventing pedestrian traffic in front of the residence to protect the public. He explained that this is a common practice for OPD when other agencies are conducting an operation in Oakland to keep the area safe for the public.

Several members expressed concern that when OPD aids ICE while it conducts an operation, that OPD is providing ICE the type of assistance in immigration/deportation actions that Oaklanders are strongly against. Members also stated that due to actions in other cities, local law enforcement are sometimes misled and inadvertently help in non-criminal immigration operations when they have been told the operation involves a more significant criminal matter.

Based on these concerns the Commission passed a motion to send a recommendation to the City Council that it conduct a public hearing on the activities of the day of the ICE operation and that the policy be changed to state that OPD will not help in any ICE Operation including providing traffic/perimeter control assistance. The motion passed unanimously.

5. 5:45pm: Receive staff status update on Surveillance Equipment Ordinance labor discussions and take possible action.

Joe DeVries provided a brief update explaining that the ordinance was being reviewed internally with OPD and a new draft would be brought back to the Commission in January.

6. 6:00pm: Subcommittee status update on ALPR policy conversion project

There was no report.

7. 6:05pm: Further discussion of citywide Privacy Initiative and Privacy Program (Seattle)

The Commission reviewed the Seattle Privacy Policy as a model for Oakland to use and an ad hoc committee was created to work with Joe DeVries and other city staff in developing a draft to bring back to the Commission in the coming months. Members Oliver, Suleiman, and Katz all agreed to serve on this committee.

Background

Oakland Police Department Lexipol Policy 609, Cellular Site Simulator Usage and Policy, requires that we provide an annual report. Section 609.7.2, Annual Report, requires that the "Cellular Site Simulator Program Coordinator shall provide the Chief of Police, the Privacy Advisory Commission, and Public Safety Committee with an annual report" that includes all of the below data points. (Sergeant Babka is currently the Program Coordinator.)

2017 Data Points

Private Video Camera Registry

610.1 PURPOSE AND SCOPE

The Private Video Camera Registry (the "Registry") is a database of private camera locations, maintained by the Oakland Police Department and the City's Information Technology Department.

The Registry allows OPD personnel to quickly and efficiently locate camera locations and contact information to assist in the investigation of crime.

The Registry is not intended for viewing live-real time video. OPD does not ask for Internet Protocol (IP) addresses to watch live video and cannot use the cameras to conduct surveillance.

610.2 CAMERA REGISTRATION

The Registry includes a web-based portal where residents and merchants voluntarily register their cameras. Owners can provide contact information, video camera location(s), and technical details about their cameras. The data that members of the public input in their online entry is populated into the database.

Members of the public can register their cameras as well as obtain information about the program at http://www2.oaklandnet.com/government/o/OPD/s/cameraregistry/index.htm.

610.3 OPD ACCESS AND USE

Access to the Registry is available only to active OPD personnel and only through a smartphone with either the IOS-(Apple) or Android-based (Google) operating system. There is no desktop computer-based Camera Registry application available for most personnel.

The Camera Registry Application Installation Manual (TF-3510) provides instructions for downloading and using the smartphone application.

The Registry application includes a geographic information system (GIS)-based mapping interface that connects to the database. The GIS mapping system enables OPD personnel to find camera locations and contact information very quickly, by tapping on the camera icon for any camera registrant.
