## MEETING AGENDA

A. Roll Call and Determination of Quorum

*Present: Martin, Goldsberry, Mercado, Chase, Turner, Floyd-Johnson, Long, Minor*  
*Absent: Yi, Tucker*

B. Open Forum / Public Comment

*Public speakers spoke in support of recently launched emergency grant program for equity applicants and raised concerns re potential criminal activity against cannabis businesses during the July 4<sup>th</sup> weekend.*

C. Review of the Pending List and Additions to Next Month’s Agenda

- *Cannabis Regulatory Commission 2019 Annual Report (since February 2020)*
- *Shared drive regarding cannabis robberies and burglaries (since February 2020)*

*Member Minor mentioned that OPD’s annual report should be available in the coming months and that East Bay Municipal Utility District representatives could be available at the next CRC meeting. Vice-Chair Martin moved to have EBMUD present at next month’s meeting. Member Goldsberry seconded the motion and it passed by consensus.*

*Vice-Chair Martin moved to agendize how the CRC can directly communicate with the City Council. Member Goldsberry seconded the motion and it passed by consensus.*

D. Approval of the Draft Minutes from the Regular CRC meeting on June 4, 2020 and the Special CRC meeting on June 11, 2020.

*Member Floyd-Johnson moved to approve the minutes as drafted. Member Long seconded the motion and it*

*passed by consensus.*

E. Reports for Discussion and Possible Action  
1. Parliamentary Procedures

*Vice-Chair Martin moved to hear Item E(2) before Item E(1). Member Floyd-Johnson seconded the motion and it passed by consensus.*

*Vice-Chair Martin provided context for the item then made a motion to recommend staff work with the City Attorney's Office to codify the process for discussing items and to bring back proposed changes to the CRC at a future meeting. Member Floyd-Johnson seconded the motion and it passed by consensus.*

2. Agencies listed on the City of Oakland cannabis permit inspection card.

*Inspector Rodrigo Jacomet provided an overview of the Building Bureau's permitting process, followed by Inspectors Miguel Villanueva and Sheryl Skillern's overview of the Fire Prevention Bureau's permitting process.*

*Public speakers asked if the Building and Fire Prevention Bureaus' powerpoints would be available online, whether fire sprinklers are necessary for cultivation operations employing few people, whether certain manufacturing operations qualify as volatile.*

*Member Floyd-Johnson asked if there was a way to require fire sprinklers in all commercial and industrial properties to put the burden on property owners to bear this cost. Fire prevention staff replied no, it depends on the activity, and property owners and tenants share the responsibility.*

*Member Mercado asked what are the City's odor mitigation requirements. Member Jacomet replied that it must be done by a licensed engineer. Member Long asked where operators can find building and fire permitting requirements. Member Minor referred to the Building and Fire Prevention Bureau Permitting Procedures available at <https://www.oaklandca.gov/topics/cannabis-permits>.*

*Last, Member Long and Vice-Chair Martin asked about shared-use facilities.*

3. Updated Assessment of Equity Program

*Member Minor and Vice-Chair Martin provided background on this project and the work done thus far by the Updated Assessment subcommittee, as well as the draft outline for the public and CRC's consideration.*

*A public speaker encouraged the assessment to examine why some operators have given up and to do a survey of equity operators.*

*Vice-Chair Martin encouraged equity operators to stay engaged with this process and to also keep in mind that running a business and a cannabis business is difficult in general. Member Floyd-Johnson recommended including the impact of Covid-19 and recent burglaries in the updated assessment.*

*Vice-Chair Martin then made a motion to incorporate Member Floyd-Johnson's recommendation, to change the title of 3A in the draft outline to an analysis of Oakland's industry overall as opposed to equity, and to request an annual report from the Revenue Management Bureau on taxes paid by cannabis businesses. Member Floyd-Johnson seconded the motion and it passed by consensus.*

#### 4. Continued Discussion re Impact of Covid-19 on the Cannabis Industry

*Member Goldsberry moved to continue this item to the next CRC meeting. Vice-Chair Martin seconded the motion and it passed by consensus.*

#### 5. Enforcement re Seshes

*Vice-Chair Martin moved to place this item on the pending list. Member Floyd-Johnson seconded the motion and it passed by consensus.*

#### 6. Continued discussion of recent burglaries of cannabis businesses and recommendations for the City Administration and City Council to support impacted businesses.

*Member Minor provided an update since the last meeting. Member Goldsberry describing ongoing communication with OPD.*

*Public speakers spoke regarding having a concealed carry permit as a deterrent and the need to warn people regarding potential burglaries of cannabis facilities this coming Fourth of July weekend.*

*Member Long urged OPD to take action this coming weekend. Member Mercado mentioned that operators who were burglarized in months/years prior felt left out of recent discussions. Member Mercado was also interested in knowing about security firms owned by women or people of color.*

*Member Goldsberry emphasized reducing the cannabis business tax rate to provide operators with the financial resources to fortify their businesses better. Member Goldsberry made a motion to revisit the cannabis business tax rate at the next CRC meeting. Member Floyd-Johnson seconded the motion and it passed by consensus.*

*Vice-Chair Martin and Member Minor discussed recent surveys of burglarized cannabis businesses and how some operators may be reluctant to fill surveys after being burglarized.*

#### F. Announcements

1. Update on Cannabis Permitting Process
2. Updates to Equity Grant Program

*Member Minor provided updates, including the recently launched grant programs for equity applicants.*

*Members then discussed security concerns for this coming weekend and how the City should warn operators. Member Floyd-Johnson made a motion to ask that the City Administrator's Office coordinate with the Oakland Police Department to notify cannabis businesses of potential crimes against cannabis businesses this coming weekend. Vice-Chair Martin seconded the motion and it passed by consensus.*

*Member Long then made a motion to agendize the creation of a Department of Cannabis. Member Floyd-Johnson seconded the motion and it passed by consensus. Member Mercado then made a motion to agendize a discussion regarding cybersecurity best practices. Vice-Chair Martin seconded the motion and it passed by consensus.*

### ITEM E (1) East Bay Municipal Utility District (EBMUD) Permitting Process for Cannabis Operators

The CRC added the agencies listed on the City of Oakland's cannabis permit inspection card to the CRC's pending list in February 2020. The item was moved by Member Goldsberry and seconded by Member-Floyd Johnson. Last month representatives from the Bureaus of Building and Fire Prevention provided an overview of their permitting processes and answered related questions. This month a representative from EBMUD will provide an overview of their process and be available for questions.

### ITEM E (2) Draft Annual CRC Report for 2019 and How the CRC Can Communicate with the City Council

Measure Z requires the CRC to report annually to the City Council on the implementation of Measure Z. Attached is a draft Annual report for 2019 based on the minutes of 2019 CRC meetings. Once the CRC finalizes the report it will be provided to the City Council.

At last month's meeting Vice-Chair Martin moved to agendaize how the CRC can directly communicate with the City Council. Member Goldsberry seconded the motion and it passed by consensus. Accordingly, this topic has been combined with the annual report item.

ITEM E (3) Revisiting Cannabis Business Tax Rate

At last month's CRC meeting Member Goldsberry made a motion to revisit the City's cannabis business tax rates at the next meeting. Member Floyd-Johnson seconded the motion and it passed by consensus.

ITEM E (4) Creation of a Department of Cannabis

At last month's CRC meeting Member Long made a motion to agendaize the creation of a Department of Cannabis. Member Floyd-Johnson seconded the motion and it passed by consensus.

ITEM E (5) Continued Discussion re Impact of Covid-19 on the Cannabis Industry

This item was initially discussed at the May 2020 CRC meeting and continued to the June 4<sup>th</sup> CRC. This item was continued again at the June 4<sup>th</sup> and July 2<sup>nd</sup> CRC meetings for the next regularly scheduled CRC meeting.

**Figure 7: Graph of Cannabis Permit Applications Received Since 2017**





Figure 8: Graph of Cannabis Permits Issued Since 2017

**I. INTRODUCTION**

In 2019 the Cannabis Regulatory Commission (CRC) continued to engage in policy discussions around the transition of the cannabis industry into the regulated marketplace and the development of the City of Oakland's Equity Program. Below is a summary of the CRC's 2019 activities and outstanding issues for the City Council's consideration.

**II. CANNABIS REGULATORY COMMISSION COMPOSITION AND ATTENDANCE**

The CRC's membership has continued to evolve. With seven new members, more than half of the CRC's current members are different than the CRC members in January 2019.

The CRC lacked quorum at four of its meetings in 2019 and a fifth meeting was cancelled due to the July 4<sup>th</sup> holiday. Since transitioning new members and filling all but one vacancy, though, the CRC has not lacked quorum thus far in 2020.

**III. CANNABIS REGULATORY COMMISSION 2019 RECOMMENDATIONS**

In 2019 the CRC made several recommendations that were adopted by the City Administration and codified by City Council. At the same time, some of the CRC recommendations have not yet been adopted and remain unresolved as described below.

## **a. 2019 Adopted Recommendations**

Below is a summary of the CRC's 2019 recommendations that were adopted by the City Administration and City Council.

### **i. Use of State Grant Funds**

In 2019 the CRC held multiple discussions regarding how the City should utilize state grant funds that became available under Senate Bill (SB) 1294 to support the City's Equity Program. The CRC's recommendations on utilizing these state funds towards revolving loans that cover equity applicants' state licensing fees, supporting shared-use manufacturing spaces, workforce development, and ongoing technical assistance were adopted by the City Administration and City Council.

### **ii. Reducing Cannabis Tax Rates**

Likewise, the CRC held multiple discussions around lowering the business tax rates on cannabis businesses. While the new rates adopted by the City Council in December of 2019 were not as low as the CRC's recommendations (see discussion in section below), the City Council did ultimately lower the tax rates for cannabis businesses.

### **iii. Changes to Dispensary Permit Process**

The CRC also made recommendations regarding the City's dispensary permit application and process that were adopted by the City Administration. For example, to address an issue that arose from the 2018 dispensary permit application process the CRC recommended requiring a dispensary permit applicant finalize its lease or purchase of a property within 90 days of receiving conditional approval at a public hearing in order to ensure they are moving forward with their dispensary project. Similarly, the CRC made recommendations on which questions on dispensary permit application deserved more weight than others. Both recommendations were adopted by the City Administration.

### **iv. Updated Equity Assessment**

Finally, in 2019 the CRC recommended conducting an updated assessment of the City's Equity Program based on recommendations developed by an equity assessment subcommittee. Staff has been meeting with the subcommittee for several months and together have drafted an outline for an updated assessment that will hopefully be completed by the end of this year after data is collected from cannabis operators and information is gathered from other relevant industries.

## **b. Recommendations Not Yet Adopted**

Below the CRC has highlighted outstanding issues for the City Council's consideration.

### **i. Use of Cannabis Tax Revenue**

At the March 2019 CRC meeting, the CRC moved that the City Council apportion a significant portion of cannabis tax revenue received towards helping victims of the war on drugs by (1) continuing the equity program and (2) community reinvestment, including workforce development programs. Currently, all cannabis tax revenue goes towards the City's general fund, other than an initial \$3 million collected between 2017-2018 that City Council allocated towards the no-interest revolving loan fund for equity operators.

### **ii. Cannabis Tax Rate**

While the City Council did lower the cannabis business tax rates, the CRC has recommended that the City adopt even lower rates. Specifically, the CRC recommended in 2019 that the City of Oakland tax all cannabis distributors at the same rate as non-cannabis businesses and all other cannabis operations at zero percent if their annual gross receipts are less than \$1 million, 0.75 percent if their annual receipts are between \$1 and \$2 million, and 1.5 percent for annual receipts over \$2 million.

### **iii. Quarterly vs. Annual Reporting to City Council**

The CRC is also interested in ensuring the City Council stays informed about discussions taking place at the CRC and has recommended reporting quarterly to the City Council as opposed to annually as prescribed in the underlying Measure Z. More frequent reporting regarding the CRC could assist the City Council in staying abreast to the constant evolution of the regulated cannabis marketplace during the first years of adult use legalization.

### **iv. Authorizing Permit Transfer for Equity Businesses**

Lastly the CRC recommended in 2019 that the City of Oakland amend its statutory restrictions on the transferring of permits to allow equity cannabis businesses to transfer their permits to non-equity businesses provided at least three years have transpired. This change would allow equity applicants with the flexibility to sell their business if they so choose and take advantage of the value of their business after three years. This three-year period coincides with the incubation period and would avoid undermining the intent of the equity program, which could transpire if the City allowed immediate

transfers of permits from equity to non-equity businesses. Staff is in agreement with this recommendation as well.
