## **ELLIS ACT FILINGS REQUIREMENTS**

## **CHECK LIST FOR OWNERS AND TENANTS**

Document		Comments
Date	Notice of Termination of Tenancy	Owner serves Notice of Termination to tenant; notice must include Forms 3 and 5 and 1/2 of relocation payment. Owner must file a copy of Notice of Termination within 10 days of serving on tenant.
Date	Form 1: Notice to RAP of Intent to Withraw Rental Unit	Owner files Form 1 with a fee of \$250 per unit . Under the Ellis Act owner must file all documents in person or via 1st class mail. If possible, owners should file Form 1 together with Form 2 (see below). The 120-day withdrawal notice period will start ONLY when RAP receives Form 1, Form 2, and the filing fee.
Date	Form 2: Certificate and Summary of Notice of Intent	Form 2 must be recorded with the Alameda County Recorder before owner files it with RAP. If possible, owners should file Form 2 together with Form 1 and filing fee (see above). The 120-day withdrawal notice period will start ONLY when RAP receives Form 1, Form 2, and the filing fee.

Date	Form 3: Notice of Interest in Re-renting Rental Unit	Tenant has 30 days from the date of displacement to notify the owner in writing that The tenant would be interested in re-renting the unit. Filing a copy with RAP is optional.
Date	Form 4: Notice to RAP of Constraints on Real Property	Form 4 must be filed within 90 days of filing Form 1 (Notice of Intent).
Date	Form 5: Notice of Entitlement of Extension of Time Terminating Tenancy to One Year Based on Disability or Age	Within 60 days of date that Form 1 is filed with RAP: Elderly or disabled tenants should serve to owner notice of their entitlement of an extension of notice from 120 days to a year.
Date	Owner response to Notice of Entitlement to Extension	If owner has received Form 5 from tenant, owner must inform RAP of tenant's entitlement to extension within 30 days of receipt.
Date	Notice of Eligibility for Additional Relocation Assistance	Within 60 days of date that Form 1 is filed with RAP: Tenants who are elderly, disabled, low-income, or who have minor children can inform owner of their right to additional \$2500 in relocation assistance.
Date	Owner Response to Request for Additional Relocation	If tenant has requested additional relocation assistance, owner has 15 days to 1) pay additional relocation assistance to tenant, or 2) request documentation from tenant demonstrating income qualification.
Date	Form 6: Rescission of Notice of Intent to Withdraw Unit from Rental Market	Owners who wish to rescind the Notice of Intent to Withdraw must complete and file Form 6 with RAP. The form must include a declaration signed by all the tenants living in the unit at the time of the Ellis Act eviction.
