B. Roll Call/Determination of Quorum/Recite AC-OCAP Promise

Roll was called by Staff M. Francisco, at 5:46 p.m. A quorum was established at 5:55 p.m. The AC-OCAP Promise was recited.

D. Presentation -Rose Cade, Alameda County Housing and Community Development Department

The Board welcomed Rose Cade, Assistant Deputy Director of Alameda County, Housing and Community Development Department. A PowerPoint Presentation was utilized to deliver an implementation update on Measure A-1, Affordable Housing Bond Issuance. R. Cade discussed AC: Boost: Down Payment Assistant Loan Program, Renew AC: Housing Preservation Loan Program, Rental Housing Programs, Labor and Contractor Policies, the Acquisition and Opportunity Fund Program and summarized the next steps in continued implementation. A questions and answers session concluded Cade's update.

1. Board Update

- E. Clemons discussed ongoing recruitment efforts for Oakland District 1, Oakland District 4 and Alameda County-Community. Staff is currently in contact with a prospective applicant for District 4. M. Francisco gave the final tally for the recruitment mailers: A total of 400 mailers were delivered, 361 to "Current Residents" in Community Services Block Grant (CSBG) Districts 1 (158), 2 (32), 3 (137), and 4 (34). The remaining mailers were delivered to libraries (17) and recreation centers (22).
- **B. Board Appointment Update** E. Clemons announced the completion of D. Walker's petition address verification for CSBG District 2. D. Walker was officially welcomed to the AC-OCAP Administering Board.

- Phase 1: Project Launch/Organizational Documents
- Phase 2: Interview/Assessment/Focus Groups
- Phase 3: Develop Roadmap
- Phase 4: Presentation to Board

Others – E. Clemons provided an update on the new Public Charge ruling, effective February 24, 2020. Non-citizen immigrants receiving public benefits such as Medicaid and Supplemental Nutrition Assistance Program (SNAP) may be deemed a "public charge". The Public Charge ruling is a ground of inadmissibility, that can be used to deny green cards and visas. This new ruling has implications for public health, as many will avoid seeking care, consequently leading to a public health crisis.
