

**1. Open Forum:**

*There were no Open Forum Speakers.*

**2. Approval of the June Regular and Retreat Minutes:**

*The minutes were approved.*

**3. Membership Updates:**

*Courtney Welch was introduced as a new member representing the Mayor's Office and filling the vacancy left by Jay Ashford's term ending. She spoke about her participation in her Neighborhood Council and Planning group.*

**4. Review OPD Policy and Procedure for Community Policing:**

*The Board spent most the meeting reviewing the Community Policing Policy document and voting on the changes proposed by the ad hoc review committee. The approved changes and recommendations that are being provided to OPD are attached. Since the Board is utilizing a modified consensus method of moving items forward, the document was unanimously supported in its final form.*

**5. Discuss CRO Training Program:**

*Captain Bolton presented the Department of Justice COPS Office approved training program that he is considering for CROs. He noted that it reinforces many of the policies already in place at OPD such as Procedural Justice Training and would serve as a good reinforcement. The training is also very affordable and there are already funds to pay for it; it will cover all the CROs and there will still be room for all the NSCs as well.*  
*There was a concern aired by Member Lerma about using a federally approved training program given the current state of affairs regarding OPD working with federal agencies such as ICE but it was pointed out that this training was approved as part of the Obama Administration's "21<sup>st</sup> Century Policing" program and was likely a good fit.*

*The Board voted in favor of supporting OPD moving forward with this training.*
